Dear Secretary,

I am writing this in the context of the need for expeditious processing of cases of revision of pension of pre-1.1.2016 pensioners in accordance with the order issued by Department of Pension and Pensioner's Welfare contained in their O.M.No.38/37/2016-P&PW(A) dated 12.5.2017. I have reviewed the situation and find that we need to attach due seriousness to this exercise.

- 2. In order to facilitate expeditious revision of pension in such cases, detailed instructions were issued by this Department as per the O.M. of even number dated 23.5.2017 brining out procedural points of action concerning various agencies involved in the exercise. Subsequently, a D.O. letter was issued by the Additional Secretary (Expenditure) on 25.5.2017 addressed to all the Secretaries of Government of India followed up by the D.O. letter from me also bearing No.CPAO/IT&Tech/Revision/7<sup>th</sup> CPC/19-Vol.III/2017-18/18 dated 27.7.2017, where I requested that clear timelines to complete the revision exercise may be drawn up and the progress should be reviewed regularly in weekly Senior Officers' meeting.
- 3. AS (Expenditure) has reviewed the progress of the exercise on a number of occasions. However, I have been informed that the matter has not yet been given due priority as it deserves, as until now very few cases of pension revision have concluded.
- 4. The Government has accorded high priority to the completion of this work timely manner. In order to put the exercise in right focus, a Committee may be set up in all the Departments under the concerned Financial Advisors, with the concerned Joint Secretary of the Administrative Wing and the CCA as members. The Committee may meet weekly and review the progress of cases of pension revision so that due priority is accorded and pension revision progresses expeditiously. It may be ensured that the concerned Joint Secretary of the Administrative Wing attends the meeting as the primary action for pension revision is to be taken by the Administrative Wing. An outcome of the review undertaken by the Committee may be furnished to this Department on a monthly basis in the proforma attached.
