2. Considering the representations received from the project staff appointed on various ICMR ad-hoc projects, it has been decided by the Competent Authority of the Council that the revised rates of Consolidated Salary so issued *vide* this Office letter of even number dated 15.2.2013 are also applicable in respect of those ad-hoc project employees who have been appointed prior to 15.2.2013 instead of 1.1.2013 intimated earlier in the Office Order as referred to above.

3. House Rent Allowance is payable with reference to the initial basic of pay plus grade pay and NPA. HRA is admissible if the place of duty falls within the qualifying limits of the City/Urban agglomeration irrespective of the place of residence & classification of cities given below:

HRA @ 30%, 20% & 10% as per revised classified of cities i.e. 'X', 'Y' & 'Z' respectively

X (Earlier classified as A-1). (30% on Pay + GP .

Y (Earlier classified as A, B-1 & B-2). (20% on Pay + GP.

Z (Earlier classified as C & Unclassified). (10% on Pay + GP.

In case of Medical Scientists NPA may also be taken into account in computation of HRA)


