Subject:- Pay scale of Rs.2650-4000 (Rs.5200-20200 + Grade Pay Rs.1800) to the Laboratory Attendant/Field Laboratory Attendant (FLA) –

Sir,

In pursuance to the order of Hon'ble CAT Chennai decision vide OA820/206 the pre-revised pay scale of Laboratory Attendant is Rs.2650-4000 instead of 3050-4590.

In supersession of this office letter of even number dated 22.6.2011 regarding the pre-revised pay scale of FLA, it is hereby informed that earlier based on Anomaly Committee recommendations some Field Laboratory Attendants/Laboratory Attendants/Field Attendants/Animal Care Attendants with Matric qualification were granted pay scale of Rs.3050-4590 instead of Rs.2650-4000. Recruitment Rules for recruitment to these posts is VIII class with relevant experience. All the above mentioned categories were eligible for promotion to the scale of pay of Rs.4000-6000 as per Recruitment Rules.


On the basis of above mentioned CAT judgement, the recommendations of the Anomaly Committee granting the higher pay scale of Rs.3050-4590 to High School qualified Laboratory Attendant stands nullified vide Council letter No.6/14/2000-Admn.II* (VCRC) dated 12.10.2006 Accordingly all Laboratory Attendants/Field Attendants/Animal Care Attendants/FLAs as per Recruitment Rules have to be granted pre-revised pay scale of Rs.2650-4000 instead of 3050-4590.

Those Laboratory Attendant/Field Attendant etc. who were earlier granted ACP to the scale of pay of Rs.4000-6000 (Rs.5200-20200+GP Rs.2400) shall not be effected by this and they will continue to be promoted to this scale as per the Recruitment Rules for Technical & Engg. Support Cadre issued on 10.2.2011. Such employees will be granted ACP in future as per MACPS rule.

In view of the above scales of all Field Laboratory Attendant/Laboratory Attendant/Field Attendant/Animal Care Attendant who were given the scale of pay of Rs.3050-4590 due to Anomaly Committee recommendations stands modified to pre-revised pay scale of Rs.2650-4000 (Rs.5200-20200+GP Rs.1800) w.e.f. 12.10.2006 and no recovery be made.

This issues with the approval of Director General, ICMR.
