

Sir/Madam,

Reference letter No. 16/169/2015-Admn.II/2 dated 5th January, 2016. The formal merger of NCLAS with NARF shall take place once the facility of NARF is ready at Genome Valley. Meanwhile in respect of NCLAs facility following may be observed as mentioned below:

- Dr. P. Suresh, Director-in-Charge, NARF will continue to be head, NCLAS as earlier.
- Existing staff of NCLAS will continue to work in NCLAS and once NARF facility is ready at Genome Valley staff will be given option for joining in NARF and whoever opts shall stand transferred along with post to NARF.
- Existing combined seniority of Administrative/Technical staff will continue for promotion purposes.
- Existing licence for animal house which is in the name of NIN will continue to remain with NIN even after shifting of NCLAS to Genome Valley facility. NARF will get a separate new licence at Genome Valley Facility.
- After the NARF at Genome Valley become fully functional, the existing small animal house facility of NCLAS will be with NIN as their animal experimentation facility for their research work.
- Once the NARF facility is ready at the Genome Valley, NCLAS will be merged with NARF and all its activities shall stand shifted to NARF, Genome Valley.
