
Subject : Placement/fixation of pay of existing Assistants/Personal Assistants and Section Officers/Private Secretaries of ICMR in 7th CPC Pay Matrix – reg.

The Executive Council in its meeting held on 30.5.2017 at ICMR Hqrs. Office has approved that the matter relating to anomaly in the grade pay of Section Officer and Private Secretary, the Grade Pay of Rs.4600/- in respect of Section Officers and Private Secretary of I.C.M.R. shall stand revised **notionally** to Rs.4800 from the date of their promotion, and they will be placed in Level-8 of the 7th CPC Pay Matrix w.e.f. 1.1.2016. Accordingly, while implementing the decision, the following may be kept in mind :-

- (a) The Grade Pay of the existing Section Officers and Private Secretaries of ICMR may be revised notionally from Rs.4600 to Rs.4800 with effect from the date of promotion or 1.1.2006 as the case may be;
- (b) There will be no change in the fixation Table (S-12) applied w.e.f. 1.1.2006 and no payment of any arrear for the period between 1.1.2006 and 31.12.2015;
- (c) Section Officer and Private Secretary will be placed in the Level-8 of the 7th CPC Pay Matrix w.e.f. 1.1.2016; and
- (d) Fresh recruitment to the post of Assistant/PA and SO/PS will be made following new Recruitment Rules and will have the Grade Pay of Rs.4200 and Rs.4600 in level-6 & level-7 of 7th CPC Pay Matrix respectively.

2. In view of the above, financial upgradation granted under MACP to the Assistants/Personal Assistants in the same grade pay of Rs.4600 may be revised to Rs.4800 notionally from the due date, and actual benefits shall accrue w.e.f. 1.1.2016. Pay of such employee will also be fixed in level-8 of 7th CPC pay matrix.
3. This is issued with the approval of the Competent Authority.
