Ltd., the SPV of M/s Pragat Akshay Urja Ltd. has failed miserably to execute the work relating to development of Solar Park under the scheme for Development of Solar Parks and Ultra Mega Solar Power Projects sanctioned vide this Ministry's order no. 30/104/2015-16 dated 29.06.2016 and thereafter, denied to return the Central Financial Assistance (CFA) of Rs. 4.10 crore already released to them causing a loss of the Exchequer.
