- ii. The candidates should upload one set photocopies of self-attested documents viz. (Academic Degrees/Certificates (10<sup>th</sup> onward), Professional Degrees/Certificates, Experience, Aadhar Card, Caste Certificate (if applicable) a single PDF file. The applications not in the prescribed format will be summarily rejected.
- iii. The Post is to be filled on purely temporary basis till the project lasts. The appointment can be terminated with one month notice from either side without assigning any reason.
- iv. Since the post is purely temporary, the incumbents selected will have no claim for regular appointments at ICMR-NIMS or the ICMR or any other institute of the Council or claim continuation of his/her service in any other project. No other benefits are admissible as per ICMR rules.
- v. No TA/DA will be paid for attending the interview.
