INDIA AFRICA HEALTH SCIENCES PLATFORM (IAHSP)

The India-Africa partnership, touted as a partnership of equals, is pillared on numerous similarities – social, financial and political. Our common concerns and fight against poverty, nutrition, sanitation, infrastructure, health and healthcare delivery, all demand innovative, sustainable and most importantly, regionally relevant solutions.

Cognizant to this demand, India is shouldering the responsibility and has taken a step forward in setting up platforms like the **India-Africa Forum Summit (IAFS)**. The landmark **IAFS III held in October 2015**, under the aegis of the Hon'ble Prime Minister of India set the tone for collaborative and mutually beneficial partnerships between the two regions. India has committed substantial support towards the development of Africa with dedicated focus on capacity building, sharing of technical know-how and globally collaborative academic linkages between the two regions.

To carry forward this vision of IAFS III in the area of public health, the Indian Council of Medical Research partnered with Ministry of External Affairs and other key Indian Ministries (H&FW; S&T; Commerce and Industry; Chemicals and Fertilizers) and several African regional scientific and research agencies to organize the first India Africa Health Sciences Meet (IAHSM) in September 2016 at New Delhi. which was attended by many cabinet ministers, policy makers, technocrats, industry representatives, leading scientists and experts from both regions as well as the international development agencies such as the Wellcome Trust, USAID, IAVI and WHO.

The deliberations highlighted the need for India and Africa to conduct joint biomedical and health research to address diseases of common concern through indigenous development of affordable drugs, diagnostics and vaccines, and also enable knowledge sharing and capacity strengthening.

Accordingly, ICMR took up the mandate to initiate and strengthen this strategic partnership in a structured and organized manner by establishing the **India-Africa Health Sciences Collaborative Platform (IAHSP)** with its Secretariat at ICMR.

Later on, a Memorandum of Understanding was signed between ICMR and the African Union (AU) on 27th March 2019 at New Delhi to formalize this partnership.

To carry forward the initiative, through a call for applications under the ICMR/AU-STRC Health Practitioners/Researchers Capacity Building Scheme, 7 Training Courses were conducted in 3 ICMR Institutes in 2019 providing training to 95 African Health Practitioners/Researchers from 26 African countries. Subsequently, next Call was announced in January, 2020 for 8 training courses (including two online/virtual courses) being offered by 4 ICMR Institutes in India under the ICMR/AU-STRC Health Practitioners/Researchers Capacity Building Scheme. Applications received for these courses have been evaluated, however the courses could not be held in India in 2020 due to the prevailing Coronavirus pandemic.

In line with the MoU, ICMR and AU-STRC have taken up the responsibility to foster and strengthen health sciences research in both India and Africa through the ICMR-AU-STRC Research Grant Scheme. As a part of this initiative, we shall be announcing the ICMR-AU-STRC Joint Call for Proposals 2020 which is aimed for Indian and African researchers to conduct and support joint research to address diseases of common concern through indigenous development of affordable drugs, diagnostics, vaccines and enable knowledge sharing as well as capacity strengthening by creating India-Africa research networks for the diseases: HIV/AIDS; Tuberculosis and Cancer to start with.

Progress Made
